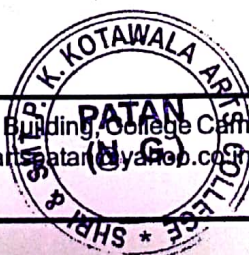
## Compliance to the resolutions taken in the IQAC meetings (Academic year: 2018-2019)
